Alekman DiTusa pledges five-year, \$100,000 commitment to The Food Bank of Western Massachusetts

Hatfield, MA – Alekman-DiTusa, a personal injury law firm based in Springfield, has recently made a charitable, five-year commitment to The Food Bank of Western Massachusetts to donate \$20,000 per year for a total of \$100,000. For each of the five years, \$15,000 of the gift will be allocated to the organization for general operating support for a total of \$75,000. The remaining \$5,000 per year will support the organization's capital campaign to build a future, greener food distribution center and headquarters in Chicopee. The new location will be significantly larger than The Food Bank's current facility in Hatfield and will allow for an expansion of food distribution services and community engagement through partnerships with 170+ food pantries and meals sites that make up the Western Massachusetts emergency food network.

Through community partnerships, The Food Bank also seeks to address long-term solutions to food insecurity and hunger through anti-hunger legislative advocacy on the local, state, and federal levels,

SNAP Outreach and Enrollment assistance, and its Food Insecurity Screening Initiative in cooperation with community health centers in the region.

Founded in 1982, The Food Bank is celebrating its 40th year of service. Since its founding, it has distributed more than 187,000,000 pounds of healthy food to food-insecure households in the region.
